FLORIDA POWER & LIGHT COMPANY'S FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION OF INFORMATION ASSOCIATED WITH TROPICAL STORM ALEX INFORMATIONAL FILING

Pursuant to Section 366.093, Florida Statutes ("F.S."), and Rule 25-22.006, Florida Administrative Code ("F.A.C."), Florida Power & Light Company ("FPL") hereby submits its First Requests for Extension of Confidential Classification of certain documents and information specified in FPL's informational filing associated with Tropical Storm Alex (the "Confidential Information"). In support of its Request, FPL states as follows.

- 1. On October 31, 2023 FPL filed a Request for Confidential Classification of the Confidential Information (Document No. 05910-2023). By Order No. PSC-2024-0023-CFO-EI, issued January 23, 2024, the Commission granted FPL's October 31, 2023 Request for Confidential Classification. FPL herein adopts and incorporates by reference the October 31, 2023 Request and Order No. PSC-2024-0023-CFO-EI.
- 2. The period of confidentiality granted by Order No. PSC-2024-0023-CFO-EI will expire on July 23, 2025. The Confidential Information that was the subject of FPL's October 31, 2023 Request and Order No. PSC-2024-0023-CFO-EI warrants continued treatment as proprietary confidential business information within the meaning of Section 366.093(3), F.S. Accordingly, FPL hereby submits this First Request for Extension of Confidential Classification.
- 3. All the information designated in Exhibits A, B and C to the October 31, 2023 Request remains confidential. Accordingly, those exhibits will not be reproduced or reattached here.

- 4. Included in this Request is First Revised Exhibit D, which consists of the declarations of Keith Ferguson and Amber De Lucenay.
- 5. The Confidential Information is intended to be and has been treated by FPL as private, its confidentiality has been maintained, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093, F.S., such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.
- 6. As stated in FPL's October 31, 2023 Request, the confidential business information includes information relating to bids or other contractual data, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms. This information is protected by Section 366.093(3)(d), F.S. The confidential business information further includes information relating to competitive interests, the disclosure of which would impair the competitive business of FPL. This information is protected by Section 366.093(3)(e), F.S.
- 7. Upon a finding by the Commission that the information contained in the Confidential Documents is proprietary confidential business information, the information should not be declassified for at least eighteen (18) month period and should be returned to FPL as soon as it is no longer necessary for the Commission to conduct its business. *See* Section 366.093(4), F.S.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials, Florida Power & Light Company respectfully requests that its First Request for Extension of Confidential Classification be granted.
