On July 10, 2025, Florida Power & Light Company (FPL or Company) filed a request for confidential treatment of Document No. 05582-2025. This document contains certain confidential information provided in response to Staff's Fourteenth Request for Production of Documents (POD), No.63. This document can be described as information related to FPL's transmission project planning, including projected load and generation assumptions.

In its request for confidentiality, FPL asserts that disclosure of this information would harm FPL, as the information relates to competitive interests. Furthermore, FPL states that the Company treats the confidential information provided in Document No. 05582-2025 as private and has not publicly disclosed it. The Company asserts that if this confidential information was disclosed, it may impair the Company's competitive business.

Staff has reviewed the documents and concurs with FPL that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair its competitive business interests. Therefore, staff recommends the request for confidential classification of FPL's response to Staff's Fourteenth POD, No. 63 in Document No. 05582-2025 be approved.
