Based on staffs review, the information provided that is related to certain documents and information provided in response to FL Rising, LULAC, and ECOSWF's 14th request for PODs contains information concerning bids or other contractual data and information related to competitive interests, the disclosure of which would impair the efforts of FPL to contract for goods and services on favorable terms. Specifically, for PODS No.s 95 and 125, the materials contain information related to negotiated consulting services agreements and invoices, and for PODS Nos. 122 and 123, is data that is proprietary to third party vendors who provided it to Concentric pursuant to a subscription agreement. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 06528-2025 be approved pursuant to Section 366.093(3)(d)(e), F.S.
