Based on staff's review, the information provided that is related to highlighted documents and information provided in third supplemental response to FL Rising, LULAC, and ECOSWF's 13th request for PODs for workpapers of rebuttal witness Tiffany Cohen contains information regarding competitive interests and disclosure of this information would impair competitive business interests. Specifically, the information contains proprietary data pertaining to projected tax impacts on revenue requirements. In addition, the documents contain information concerning bids or other contractual data, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms. Specifically, the information contains a Memorandum of Understanding used between FPL and certain large commercial customers. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 05740-2025 be approved pursuant to Section 366.093(3)(d)(e), F.S.
