On July 21, 2025, the City of Clearwater d/b/a Clearwater Gas System (CGS) submitted a letter notifying the Commission that as of July 7, 2025, CGS changed its name to City of Clearwater d/b/a CGS Energy. This was for a name change only and no change of ownership or transfer of assets is involved.

By its July 21 letter, CGS requests that the Commission administratively update its records to reflect the change of name (applicable to Company Code GS005). CGS also stated that the contacts designated for the utility to receive notices, orders, data requests, and other communications from the Commission, remain unchanged, but email addresses will require a change of the suffix to cgsenergy.org. Mail should be addressed to CGS Energy.

CGS provided notice of the name change to the Pipeline and Hazardous Materials Safety Administration (PHMSA) National Registry on July 16, 2025.
