

By Order No. PSC-2025-0285-PAA-WU, issued July 22, 2025, in Docket No. 20240119-WU, the Florida Public Service Commission (Commission) approved the application for staff-assisted rate case in Polk County, by Alturas Water, LLC (Utility). The monthly rates you were paying to the utility increased and was approved by the Commission. In addition, the Commission approved an increase to miscellaneous service charges and conformed the charges pursuant to Rule 25-30.460, Florida Administrative Code.
