As Florida Power and Light already has automatic annual rate raises of 5% per year, I find it reprehensible that additional increase/increases could even be considered. I am a retired person on a limited and my FPL bill being by far my highest monthly bill, I would be seriously impacted negatively by any increased raises. Please do not allow this to happen. I am certain that such raises would go to the executives of FPL. They already rake in large incomes.

I am a residential customer of Florida Power & Light (FPL) and a member of AARP, and I oppose FPL's attempts to raise its rates even higher than they already are. These

Enough is enough — protect residential customers from corporate greed and unjustified rate hikes.
