NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that Florida Power & Light Company's petition for variance of Rule 25-6.0143(1)(g), Florida Administrative Code, filed July 31, 2025, in Docket No. 20240149-El, In re: Petition for limited proceeding for recovery of incremental storm restoration costs related to Hurricanes Debby, Helene, and Milton, was approved by the Commission by Order No. PSC-2025-0342-PAA-El, issued September 12, 2025, and consummated by Order No. PSC-2025-0371-CO-El, issued October 6, 2025. The rule addresses, in relevant part, the September 30 filing date for requesting recovery of final storm restoration costs and true-ups. The petition was approved on the basis that the purpose of the underlying statute would be achieved by other means and application of the rule would create substantial hardship.
