

**SEBRING GAS SYSTEM, INC.'S
PREHEARING STATEMENT**

Sebring Gas System, Inc. (“Sebring”) hereby submits this Prehearing Statement pursuant to Order No. PSC-2025-0051-PCO-GU, issued February 10, 2025, establishing the hearing procedures and controlling dates in this docket, and states as follows:

a. All Known Witnesses

c. Statement of Basic Position

The Commission should approve Sebring’s respective final net true-ups for the period January through December 2024, the estimated true-up for the period January through December, 2025, and the projected conservation program expenses and recovery factors for the period January through December, 2026.

d. Position on the Issues

ISSUE 1: What are the final conservation cost recovery adjustment true-up amounts for the period January 2024 through December 2024?

Sebring: Final adjusted true up amount for the period is an over-recovery of \$1,773.

ISSUE 2: What are the appropriate conservation adjustment actual/estimated true-up amounts for the period January 2025 through December 2025?

Sebring: The appropriate actual/estimated true up for the period, net of the prior period adjustment, is an under-recovery of \$4,272.

ISSUE 3: What are the appropriate total conservation adjustment true-up amounts to be collected/refunded from January 2026 through December 2026?

Sebring: The appropriate amount to be recovered is an under-recovery of \$2,500.

ISSUE 4: What are the total conservation cost recovery amounts, net of the true-up amount, to be collected during the period January 2026 through December 2026?

Sebring: The projected conservation costs for January 2025 through December 2025 are projected to be \$45,695, which results in a total amount of \$48,195 to be recovered during the period January 2026 through December 2026.

ISSUE 5: What are the conservation cost recovery factors for the period January 2026 through December 2026?

Sebring: Sebring’s proposed conservation cost recovery factors for 2026 are:

TS-1	\$0.15845
TS-2	\$0.07183
TS-3	\$0.04550

TS-4

\$0.04041

ISSUE 6: Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

Sebring: Yes. The Commission should approve revised tariffs reflecting the new energy conservation cost charges determined to be appropriate in this proceeding. The Commission should direct staff to verify that the revised tariffs are consistent with the Commission's decision.

ISSUE 7: What should be the effective date of the new conservation cost recovery factors for billing purposes?

Sebring: The new conservation cost recovery factors should be effective for all meter readings on or after January 1, 2026 and should apply to bills rendered for meter readings taken between January 1, 2026 and December 31, 2026.

ISSUE 8: Should this docket be closed?

Sebring: Recognizing that this is an ongoing cost recovery docket, this docket should remain open with a new docket number assigned for the following year.

e. Stipulated Issues

While not a party to stipulations at this time, Sebring believes that it should be possible to reach a stipulation on each of the issues as they pertain to Sebring.


