St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Revised Prehearing Statements for the hearing scheduled to commence in the proceeding **November 4 -7, 2025**.

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve- month period ending December 31, **2024** including interest, the projected conservation program expenses for the twelve-month period ending Dec 31, **2025** and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve-month period ending December 31, **2026** as filed by SJNG.

D. SJNG's position on each issue:

ISSUE 1. What are the final conservation cost recovery adjustment true-up amounts for the period January **2024** through December **2024**?

SJNG Position: \$62,434 over-recovery.

ISSUE 2. What is the appropriate conservation adjustment actual/estimated true-up amounts for the period January through December 2025?

SJNG's Position: \$86,015 under-recovery.

ISSUE 3. What is the appropriate total conservation adjustment true-up amounts to be collected/refunded from January through December 2026?

SJNG Position: \$23,581 under-recovery.

ISSUE 4. What is the total conservation cost recovery adjustment true-up amounts to be collected during the January through December 2026 period.

SJNG Position: \$118,956 under-recovery.

ISSUE 5. What are the conservation cost recovery factors for the period January 2026 through December 2026?

SJNG Position: The appropriate factors are:

RS-2	\$0.19986
RS-3	\$0.14613
GS-1	\$0.09243
GS-2	\$0.06071
GS-4/TS-4	\$0.03308

ISSUE 6. What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG Position: The effective date should be January 1, 2026.

ISSUE 7. Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery factors determined to be appropriate in this proceeding?
