**DUKE ENERGY FLORIDA, LLC'S (DEF), RESPONSE TO  
STAFF'S THIRD DATA REQUEST REGARDING PETITION FOR A LIMITED  
PROCEEDING TO APPROVE SECOND SOLAR BASE RATE ADJUSTMENT**

**Docket No. 20250134-EI**

1. Please refer to the DR1 Q3 response,
  - a. The Turnpike Solar Center line two reflects a carrying charge of \$5.1 million. However, Exhibit VG-8 page one, the carrying charge reflects \$6.0 million. Please verify which carrying charge is correct.
  - b. Please provide the calculation of line three with the correct carrying charge.
  - c. Please provide the Excel file with the updated carrying charge information, with formulas and calculations intact, for the chart provided in response to staff's first data request question three.

**Response:**

- 1(a). There are two components with carrying charges, which are listed separately in the response to DR1 Q3. Line two shows the solar production component with a carrying charge of \$5.1M, and Line twelve shows the network upgrade component with a carrying charge of \$0.9M. Exhibit VG-8 page one shows the consolidated carrying charge for the entire Turnpike project as \$6.0M.
- 1(b). Line two shows the correct carrying charge of \$5.1M on the solar production component of the project. No recalculations are required.
- 1(c). The carrying charge information previously provided is correct, no updates are required.
