**SECTION 63.71 APPLICATION OF GRANITE**

Granite Telecommunications, LLC (“Granite” or the “Company”) hereby applies for authority under Section 214(a) of the Communications Act, as amended, 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission’s (“Commission”) rules, 47 C.F.R. § 63.71, to discontinue legacy TDM-based voice service in certain wire centers located in 17 states.

**INTRODUCTION**

Through this application, Granite seeks to discontinue legacy TDM-based voice service (“Affected Service”). This legacy voice service is often referred to as plain old telephone services or “POTS.” Granite seeks to discontinue this service in portions of wire centers in 17 states (“Affected Service Area”) in which AT&T is discontinuing the same service.

Granite provides the Affected Service on a resale basis. The Company purchases legacy TDM-based voice service from AT&T on a wholesale basis (“AT&T Wholesale POTS”) and resells that service to end user business customers in the Affected Service Area. On June 30, 2025, AT&T notified Granite that it is discontinuing AT&T Wholesale POTS effective on or after June 30, 2026.

Once AT&T completes this discontinuance process, Granite has no choice but to discontinue the Affected Service in the Affected Service Area. At the same time, customers have cost-effective alternatives to choose from as alternatives for the Affected Service in the Affected Service Area. These options include Granite's EPIK service, which is a cutting-edge Managed Facilities-based Voice Network ("MFVN") voice service, as well as Granite's industry-leading VoIP and cloud voice services, and Granite's resold cable managed VoIP services.

## APPLICATION

### I. The Adequate Replacement Test Is Satisfied

On August 25, 2025, the Commission deemed automatically granted AT&T's application to discontinue legacy TDM-based voice service (including AT&T Wholesale POTS) in the Affected Service Area.<sup>1</sup> In its application, AT&T asserted that AT&T Phone for Business – Advanced (APB-A) satisfies the Commission's Adequate Replacement Test,<sup>2</sup> and AT&T relied on that assertion in seeking streamlined treatment of its application under the Commission's rules governing technology transitions.<sup>3</sup> Given that the Commission granted AT&T's application on a streamlined basis, it follows that AT&T's APB-A service satisfies the Adequate Replacement Test

for purposes of this application as well. In addition, while Granite does not rely on its own service offerings to meet the Adequate Replacement Test, Granite's EPIK service also meets the Adequate Replacement Test and delivers service quality that is superior to AT&T's APB-A service.<sup>4</sup>

## **II. Additional Information Required by 47 C.F.R. §§ 63.71, 63.602, and 63.505.**

As required by Sections 63.71, 63.602, and 63.505 of the Commission's rules, Granite provides the following information:

### **Name and Address of Carrier:**

### **Date of Planned Service Discontinuance:**

Granite plans to discontinue the Affected Service in the Affected Service Territory on or after June 30, 2026, pending regulatory approval (including state approvals if required) and effective when AT&T Wholesale POTS is discontinued.

### **Points of Geographic Areas of Service Affected:**

Granite plans to discontinue the Affected Service in the areas where AT&T has stated it will discontinue AT&T Wholesale POTS, which is in sections of 17 states: Alabama, Arkansas, Florida, Georgia, Indiana, Kentucky, Louisiana, Michigan, Missouri, Mississippi, North Carolina, Ohio, Oklahoma, South Carolina, Tennessee, Texas, and Wisconsin. Exhibit 1 identifies the list of wire centers in each state that include any service areas that fall within the Affected Service Area, as defined by AT&T.

**Brief Description of Type of Service Affected:**

Granite plans to discontinue its TDM-based business local exchange service in the Affected Service Area. That service provides individual business customers with telecommunications service within a specified geographical area for local calling and access to and from the telecommunications network for long distance message telecommunications service.

**Brief Description of the Dates and Method of Notice to All Affected Customers and Other Required Parties:**

Customer notices were sent to all Granite customers of the Affected Service in the Affected Service Area. Granite has previously obtained express, verifiable, prior approval from all of its customers to send notices via email regarding their service. Granite sent customer notices via email to customers of the Affected Service in the Affected Service Area between August 15, 2025 and August 30, 2025. Between August 2025 and the present, Granite followed up with customer email recipients to ensure that they are able to transition to an appropriate replacement voice service. Customers for whom Granite does not have an email address that is sufficiently reliable and customers whose email notice was returned as undeliverable were sent customer notices via U.S. mail on January 23, 2026. Finally, to comply with Michigan law, Granite sent separate notices to all customers of the Affected Service in the Affected Service Area in Michigan via U.S. Mail on January 29, 2026. Examples of these customer notices are attached hereto as Exhibit 2.

Copies of this Application are being sent via first class U.S. Mail to the governor, public utility commission, federally recognized tribes (if any) in the Affected Service Area, and to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of

the Commission's rules.<sup>5</sup> A certificate of service certifying that copies of this application were sent to these government recipients is attached hereto as Exhibit 3.

**Regulatory Classification of Carrier:**

Granite offers the Affected Service pursuant to non-dominant carrier regulation.

**Public Convenience and Necessity:**

Granite seeks the Commission's approval to discontinue the Affected Service in the Affected Service Area because AT&T is discontinuing its wholesale provision of that service. As stated, Granite provides the Affected Service by purchasing AT&T Wholesale POTS and reselling that service to end user business customers in the Affected Service Area. Granite cannot purchase POTS from any other carrier because no carrier other than AT&T provides POTS in the Affected Service Area, and Granite cannot provide the service any other way. On June 30, 2025, AT&T notified Granite that it is discontinuing AT&T Wholesale POTS effective on or after June 30, 2026. Exhibit 4 contains the wholesale service discontinuance notification that AT&T sent to Granite for the AT&T Wholesale POTS purchased by Granite pursuant to the parties' Local Wholesale Complete Agreement and pursuant to the parties' interconnection agreements. The discontinuance of AT&T Wholesale POTS will effectively discontinue Granite's retail POTS service (i.e., the Affected Service) in the Affected Service Area.

Granting this application is consistent with the public convenience and necessity. To begin with, it is sound public policy for the Commission to grant resale carriers like Granite the

authorization to discontinue services where their underlying wholesaler's decision to discontinue leaves the reseller no alternative but to do the same.

At the same time, customers have cost-effective alternatives to choose from as alternatives for the Affected Service. These options include Granite's EPIK service, which is a cutting-edge MFVN solution. Granite's EPIK service enables end users to utilize their analog devices to receive voice service via a wide range of underlying transmission technologies, softswitch technology, Ethernet, FSX, and LTE. EPIK is superior to typical SIP or wireless voice offerings because it meets the technical requirements for specialty dial-tone based applications, such as fire and safety systems.<sup>6</sup> As explained, EPIK also provides service quality that is superior to AT&T's APB-A service on wide range of service quality measures.<sup>7</sup> Finally, Granite also offers industry-leading VoIP and cloud voice services as well as resold cable managed VoIP services.<sup>8</sup>

AT&T filed its own application for Commission approval to discontinue its retail POTS in the Affected Service Area.<sup>9</sup> The POTS offerings covered by the AT&T application include the same services as AT&T Wholesale POTS and the same Affected Service Area at issue in this application. The Commission's public notice announcing its acceptance of the AT&T application

stated that, in accordance with section 63.71(k)(3) of the Commission's rules, the AT&T application was to be deemed granted automatically on August 25, 2025.<sup>10</sup> The same policy justifications support granting the instant application on a streamlined basis.

**Statement Identifying the Application as a Technology Transition (47 C.F.R. § 63.602(a)(2)):**

The proposed discontinuance constitutes a "technology transition," because Granite's remaining voice customers in the Affected Service Area will be required to replace their TDM-based voice service with a different technology or transmission medium once Granite discontinues the legacy TDM-based voice services in the Affected Service Area, as there is no other TDM-based voice service available in the Affected Service Area.

**Information Regarding the Price of the Service for which Discontinuance Authority is Sought and the Price of the Proposed Replacement Service (47 C.F.R. § 63.602(a)(3))**

The average price for all customers of Granite's TDM-based voice service is approximately \$106 per month, plus taxes, surcharges, and fees. The average price for EPIK service is approximately \$43 per month, plus taxes, surcharges, and fees. AT&T has stated that its APB-A service for business customers is available for \$99.99 per month, plus taxes, surcharges, and fees.<sup>11</sup>

**Certification that the Information Submitted in the Application is True and Accurate (47 C.F.R. § 63.602(a)(4)):**

**Applicable Tariff Listing 47 C.F.R. § 63.505(e)):**

EPIK is not a tariffed service. AT&T has stated that APB-A is also not a tariffed service.<sup>12</sup>

**Name of any other Carrier or Carriers Providing Telephone Service to the Community 47 C.F.R. § 63.505(g)):**

No other providers offer legacy TDM-based voice service in the Affected Service Area. However, as explained, Granite and AT&T both offer competitive voice services in the Affected Service Area in addition to other service offerings provided via cable, fiber, fixed-wireless, satellite, CMRS, and over-the-top service.

**Description of any Previous Discontinuance, Reduction, or Impairment of Service to the Community Affected by the Application 47 C.F.R. § 63.605(j)):**

On March 17, 2025, July 16, 2025, and October 15, 2025, Granite previously grandfathered the Affected Services in parts of the Affected Service Area.

**Number of Toll Messages 47 C.F.R. § 63.505(l)):**

AT&T has stated that toll traffic in the Affected Service Area will likely decrease in the future. Granite does not track monthly number of toll messages or toll revenues in the Affected Service Area.<sup>13</sup>
