On January 29, 2026, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 00750-2026. This document contains information concerning TECO's competitive bidding process, provided in response to Commission staff's First Data Request.

In its request for confidentiality, TECO contends that the document contains information, the disclosure of which would impair its ability to contract for goods and services. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 00750-2026 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with TECO, that the nature of the information meets the requirements set forth in Section 366.093(3)(d), Florida Statutes, whereby disclosure of the information would impair its competitive business interests and ability to contract for goods and services on favorable terms. Therefore, staff recommends the request by TECO for confidential classification of Document No. 00750-2026 be approved.
