Hello,

My name is Rex Wilson, a senior citizen and Duke Energy customer in Orlando, FL. I am writing to complain about Duke Energy's cost increases for power. In case you haven't read nextdoor.com, there are also numerous people complaining about Duke and relating it to government officials allowing this to happen by approving increases. The screen prints below show a comparison as provided by Duke Energy of my bill from January, 2025 and January 2026. First, notice that the billing period days are exactly the same number. Next, notice that the bill in January of 2025 was \$96.40 versus 109.98 in January, 2026. Logically, one would deduce that the usage was higher in January, 2026 to account for the higher bill or \$13.58 difference. However, further analysis of the 2nd two screen prints shows that 528 KWh was used in January, 2025 versus 475 KWh in January 2026. That is 53 KWh less in January, 2026 and the bill was \$13.58 more. Further analysis shows that the temperature in January, 2025 was 56 degrees versus 59 degrees in January, 2026. That means it was 3 degrees warmer in January, 2026 which should further reduce heating and associated billing costs. The dollar cost for electricity increased 14.08%. But although that is a huge percentage increase, it is not factoring using 53 KWh less in January, 2026 which would make the increase much more. The true increase is closer to 24% from January 2025 to January 2026. When was the last time anyone received an increase of 24% in Social Security or for that matter a paycheck unless there is a 900% bonus tied to a compensation package similar to some CEOs of power companies. How can Duke Energy justify such large increases? And how can our political representatives and their associated appointees allow this to happen!

And after that huge billing increase, Duke sends out the following text:

Duke Energy: Several days of sustained low temperatures are driving unusually high energy demand in our area & available power supplies are currently very limited. You can help us protect the electric grid & avoid possible temporary outages by cutting back on nonessential energy use Monday morning from 5am-9am. We appreciate any assistance you are able to provide. Get energy-saving tips at [//duk.us/176](https://duk.us/176). Text STOP to cancel.

Perhaps, Duke Energy can explain why the grid has not been upgraded to handle the energy demand since there are huge increases in our bills. Or our politicians and their appointees can investigate in detail where all the money is being spent. I urge Duke Energy, our representatives and their appointees to stop these huge increases and even reverse these huge cost increases for power to **residential consumers**. Perhaps more states need to push back on Duke Energy like Indiana as mentioned below. I also included a copy and paste of the most recent nextdoor.com complaints about Duke bills. I noticed that **Duke tends to bill for more days in periods of higher usage which pushes most people over the 1000 KWh threshold triggering higher rates. Perhaps, Duke should consider increasing this 1000 KWh threshold or adjusting the billing periods to fewer days.** And by the way, the meters are read electronically not manually so there should not be much of an issue to adjust number of days in the billing period. Last, I just received an email from Duke that they will be lowering the electric bill by some \$44 per 1000 KWh, but only after Duke Energy receives the windfall from profits from the record cold period.

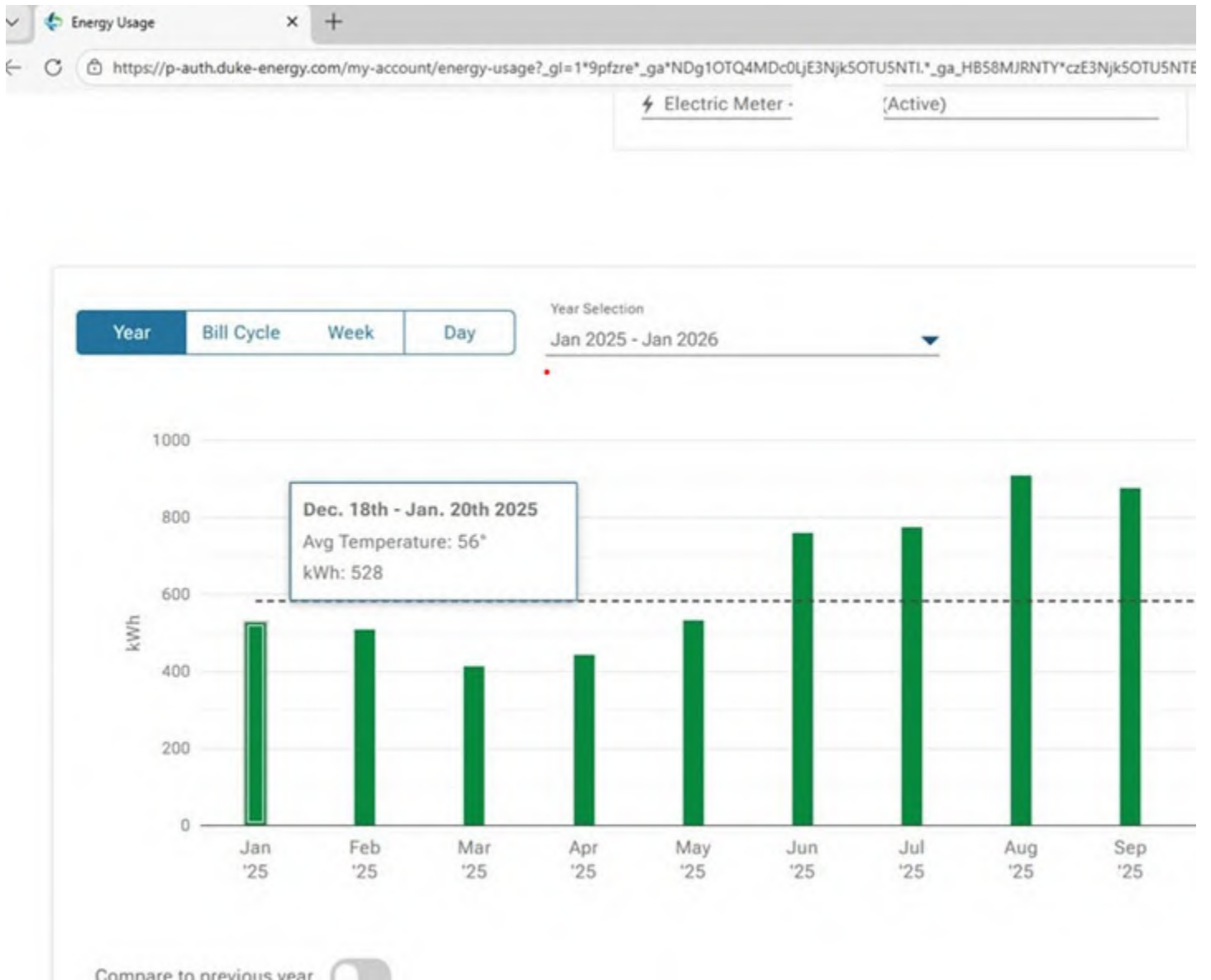
Some key points for thought can be obtained just by a quick google search.

- **Industrial & Data Center Demand:** Rapid regional growth, including massive data center projects from companies like Amazon, requires the company to add over [13 GW of capacity](#) by 2030.
- **Massive Capital Spending:** To modernize the grid and meet this demand, Duke Energy plans to invest between **\$87 billion and \$100 billion** over the next five to ten years

A primary hurdle for Sideris is keeping electricity bills manageable while funding these multi-billion-dollar investments.

- **Rate Hikes:** Duke Energy is seeking significant rate increases, including a [double-digit hike request](#) in North Carolina that could raise average residential bills by over **15-18%** starting in 2027.
- **Political & Public Backlash:** North Carolina Governor Josh Stein and other officials have formally opposed these hikes, arguing they are [too high for struggling families](#).
- **Natural Gas vs. Renewables:** The company's 2025 Carbon Plan has been criticized by advocates for [delaying coal retirements](#) and doubling down on new natural gas plants.
- **Nuclear Uncertainty:** While new nuclear projects are under consideration, Sideris has noted that [cost overruns and supply chain issues](#) must be resolved before moving forward with Small Modular Reactors (SMRs) or larger units.
- **Stock Performance:** Duke Energy's stock has recently faced pressure due to [rising interest expenses](#) and high leverage.
- **Regulatory Pushback:** In some jurisdictions, like Indiana, regulators have approved [significantly less revenue](#) than the company requested, complicating its ability to fund new projects

So, those extended months makes bills high. When usage is high due to very cold or very high temperatures, the bill cycles are longer. When usage is low, they cut bill cycles short. I contacted Duke last year about this pattern. I was told they can't control the amount of days in the bill cycle. This is ludicrous! A really important thing about those 34 day bills is that they get to charge you extra for all of those days kWh above 1000, simply because they added 4 standard days of use for your bill. You'd pay significantly less for those four days of kWh if they were on the next standard 30 or 31 day bill. But there is no pro-rating, they just rope all extra 4 days into the higher charge rate. It's very class action lawsuit, to me. If you billed me for 30 days, I wouldn't be paying extra for the several hundred kWh I use during the four days following the bill cutoff. You shouldn't be able to extend the billing period, charge more for the days you decide to rope in, and ALSO cause me to have to pay way more taxes on that value in the taxes section. The common people are getting snowed regularly here.
