Specifically, the information is data that is proprietary to a third-party vendor who provided it to Concentric due to a subscription agreement. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 06759-2025 be approved pursuant to Section 366.093(3)(e), F.S.
