Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") requests confidential classification of certain information sent in response to staff's 14th set of interrogatories ("ROG"). More specifically, the information which confidentiality is sought relates to ROG No. 267.

According to FPL, the confidential information contains information relating to FPL's competitive interests, the disclosure of which would impair the competitive business of FPL. Specifically, the documents contain fuel price forecasts, which if made public could impact fuel prices paid by FPL to the detriment of its customers.

Staff has reviewed FPL's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04454-2025 be approved.
