




Pursuant to Section 2.07(2)(d)(4) of the Commission's Administrative Procedures Manual, the Office of the Commission Clerk may administratively close dockets upon the joint recommendation of the OPR division and GCL.

Docket No. 20250138-TP was initiated on November 17, 2025, by the filing of an application for designation as an eligible telecommunications carrier in the State of Florida, by LTE Wireless Inc. On February 19, 2026, the utility withdrew its petition.

Staff has determined that there are no pending issues that need to be addressed by the Commission regarding the filing and no request for refund of filing fee has been made. Staff and GCL therefore jointly recommend that Docket No. 20250138-TP be closed.
