On April 9, 2020, Duke Energy Florida, LLC, (“DEF”) filed its Request for Confidential Classification of certain information contained in the Joint Proposed Recommended Order (PRO) PCS, Staff & OPC in docket 20200001 (DN 01877-2020).

By Order No. PSC-2020-0376-CFO-EI, dated October 16, 2020, the Commission granted DEF’s request. DEF filed its First Request for Extension of Confidential Classification on April 18, 2022 which was granted by Order No. PSC-2022-0160-CFO-EI. DEF filed its Second Request for Extension of Confidential Classification on October 9, 2023 which was granted by Order No. PSC2024-0423-CFO-EI.
