Gentlemen:

Attached are an original and two copies of the annual report form for Farmton Water Resources LLC for the year ended December 31, 2005. Only the first page, general information, has been completed, since the utility was not a regulated entity until shortly before year end. We were not yet providing service for compensation as of December 31; therefore, there are no operations result to report as of year end 2005.

As you know the Commission issued its order PSC-04-0980-FOF-WU granting Farmton a certificate to operate a water utility on October 8, 2004. However, two governmental entities appealed that decision. The order of the Commission was upheld on appeal and Farmton's original certificate 622-W was issued on December 6, 2005. As a result, Farmton was preparing to provide service at year end but had not begun operations as a regulated utility as of December 31, 2005.
