.22 Sprint Complete Sense for Business (Continued)

The following bundled services are for use by business customers. If it is determined that usage is not consistent with business voice applications or in any way violates the restrictions of this service, the customer's service may be assessed a \$100.00* monthly recurring data charge or Sprint may terminate the customer's service.

Customers who are subscribed to two or more Sprint Complete Sense for Business Bundles will receive a 20% discount on their Monthly Recurring Charge (MRC) for their second and each additional bundle. (R)

Sprint will prorate all charges and associated usage in the initial month and last month of service based on a 30-day month.

.1 Sprint Complete Sense for Business Basic **

A Sprint Complete Sense for Business Basic customer will pay a monthly recurring charge. The customer is able to use direct-dialed IntraLATA toll, in-state and state-to-state Dial-1 calls at the rate specified in Section 6.1.22.1 of this tariff.

.2 Sprint Complete Sense for Business Basic with International **

A Sprint Complete Sense for Business Basic with International customer will pay a monthly recurring charge. The customer is able to use direct-dialed IntraLATA toll, in-state and state-to-state Dial-1 calls at the rate specified in Section 6.1.22.2 of this tariff. Discounted international rates apply.

* This charge is identical to and shall not be in addition to any monthly recurring data charge applicable to companion Federal Service or to companion local exchange service.

**Effective January 31, 2005, Sprint Complete Sense for Business Basic and Sprint Complete Sense for Business Basic with International will no longer be available to new customers.
