EXECUTIVE SUMMARY

Introduction

BellSouth Centrex RingMaster is an optional terminating line feature that utilizes distinctive alerting for an incoming call based on whether the called directory number (DN) is the primary DN [Centrex primary line] or a secondary DN [RingMaster line] associated with a single Centrex station link. The subscriber can have up to three telephone numbers associated with a single line.

BellSouth Centrex Ringmaster allows customers to “share” a line while providing individual employees with individual telephone numbers. The individuals can identify their calls vs. their peers with the distinctive ring. In addition, through the use of enhanced SDN, each individual should be able to forward their calls to separate voicemail boxes.

This feature will only be provided for BellSouth Centrex Service and is not available for ESSX or MultiServ customers even by Special Assembly. The service will be consistent with the POTS offering for business lines to leverage existing operations and system investments.

Description of Proposed Tariff

BellSouth Centrex RingMaster will be an optional feature for BellSouth Centrex Service. It will be added to the existing BellSouth Centrex tariff optional features (A12.25.12). Likewise, the POTS Ringmaster tariff section (A13.34.2) will be updated to include Centrex Service.
