## Promotion Description

### **BellSouth Integrated Solutions**

#### **OVERVIEW OF PROMOTION**

BellSouth plans to extend the existing BellSouth Integrated Solutions (BIS) special promotion until April 30, 2007. Additionally, effective January 1, 2007, this promotion will be modified to relax the requirements for the thousand dollar (\$1000) reward check for existing BIS customers who renew their contracts. All other promotion specifics remain unchanged.

#### **Promotion Modification**

Effective January 1, 2007, the thousand dollar (\$1000) reward check qualifications are as follows:

BIS DIA (Option 3) customers who sign a new 36 month agreement are eligible to receive a one thousand dollar (\$1000) reward check provided the following conditions are met:
