Overview

The Saves \$25 Reward promotion is extended to 10/31/2007. A \$25 Saves Closer Coupon would be available to existing residential customers who contact BellSouth to disconnect service in attempt as an incentive to prevent the customer from disconnecting their local service. Customer must retain 2-Pack or Preferred Pack feature package.
