## **Promotion Description**

### **Saves Desk \$50 Reward for Packages Closer Coupon #1571**

#### **Overview**

The Saves Desk \$50 Reward for Packages Closer Coupon promotion that began on 10/1/2007 and is scheduled to end on 1/31/2008, is extended to 5/31/2008. A \$50 Saves Closer Coupon would be available for SAs to use when existing residential customers contact BellSouth to disconnect service in attempt to prevent the customer from disconnecting their local service. Customer must retain Complete Choice or Area Plus with Complete Choice feature package.

#### **Promotion Specifics**

Existing residential customers who contact BellSouth and request to disconnect their service will be eligible to receive a \$50 Reward if they agree to extend their service with BellSouth. Reward is limited to customers who purchase a Complete Choice or Area Plus with Complete Choice feature package.

#### **Promotion Restrictions/Eligibility Requirements**

1. Customer must retain Complete Choice or Area Plus with Complete Choice feature package plan.
