Overview

The Saves Desk \$50 Reward for Packages Closer Coupon promotion is extended through June 7, 2008. A \$50 Saves Closer Coupon would be available for SAs to use when existing residential customers contact BellSouth to disconnect service in attempt to prevent the customer from disconnecting their local service. Customer must retain Complete Choice or Area Plus with Complete Choice feature package.

Promotion Specifics

Existing residential customers who contact BellSouth and request to disconnect their service will be eligible to receive a \$50 Reward if they agree to extend their service with BellSouth.
