Line Connection Waiver Promotion

Overview

The Line Connection Waiver Promotion is scheduled to begin on 01/01/2010 and end on 12/31/2010.

This promotion is an offer available to business customers who bring their local exchange service to AT&T from another local exchange. Subscribers who participate in the Program and subscribe to service at a new AT&T location will not be billed for the Service charges (i.e. Line Connection Charges and/or any appropriate change in service charges associated with the service order). This promotion will begin on January 1, 2010 and go through December 31, 2010.
