CC. EMBARQ **BUSINESS** REWARDS PROGRAM

For the purpose of this sub-section A13.CC. concerning the EMBARQ Business Rewards Program, the term "Embarq" refers to Embarq Florida, Inc. and all Embarq Local Operating Company affiliates. The term "Company" refers solely to Embarq Florida, Inc.

EMBARQ Business Rewards Program ("Program") is an Embarq business customer loyalty program. The program allows customers who meet certain criteria set by the Company to earn Rewards Dollars that can be redeemed for various travel and entertainment products/services or other non-telecommunications/non-regulated products and services. Available Rewards options may change at the discretion of the Company and are provided for customer redemption on an availability basis. The Company does not guarantee availability of any option. In order to redeem Rewards Dollars, program participants must be current on payment of all their Embarq account(s).

All business customers who subscribe to services provided by the Company under this tariff and/or to Embarq High-Speed Internet (each an "Eligible Service") are eligible for enrollment in the Program. There is no charge to enroll and no term or volume commitment associated with the Program. Customers may terminate their participation in the Program at any time by notifying the Company. Eligible customers may activate their enrollment in the Program by calling an Embarq business office or in response to targeted Embarq contacts with eligible customers.

Customers enrolled in the Program will receive one Rewards Dollar for each dollar of Qualifying Usage (as defined below) the customer spends on Eligible Services. Qualifying Usage is calculated based upon the sum of the customer's monthly recurring charges for Eligible Services usage, less any applicable discounts, taxes, surcharges, FCC charges, 911 charges, or nonrecurring charges. Nonrecurring charges include service connection charges and installation charges. Rewards Dollars will accrue monthly based on the customer's Qualifying Usage. Qualifying Usage only may accrue after the customer enrolls in the Program. To earn Rewards Dollars, the enrolled customer must have an active account and that account must be in good standing, as determined by Embarq. Rewards Dollars have no direct monetary value, have no cash surrender value, and are only good towards redemption of the various products/services provided by Embarq.

In addition to the standard Rewards Dollars earned as outlined in this tariff, participants may, from time to time, be awarded additional Rewards Dollars (including bonus rewards) based upon specific purchases or actions. Consistent with applicable Commission requirements, a separate promotional filing will be made with respect to any such rewards that are based upon the purchase of regulated products or services or subscription to other tariffed offers.

Program participants may change their service address within an Embarq service territory, add additional qualifying services, or make changes to the telephone numbers(s) associated with their enrolled account(s) and still continue as a Program participant. If a Program participant discontinues subscription to all Eligible Services, Program participation will be terminated and all accumulated and unredeemed Rewards Dollars will be forfeited, unless such customer maintains Program eligibility based upon spending with other participating Embarq companies. A Program participant may not redeem Rewards Dollars against a canceled account. If the former Program participant (1) returns to Embarq for the same or substantially equivalent services within ninety days of terminating services; (2) re-enrolls in the Program; and (3) requests reinstatement of forfeited Rewards Dollars, such Rewards Dollars will be reinstated.

If a program participant fails to "actively participate" in the Program during any one-year period following Program enrollment, Program participation will be terminated and all accumulated and unredeemed Rewards Dollars will be forfeited. "Actively participate" means any of the following activities: activating their account online, rewards redemption, logging onto the Program website, contacting the Company's service center responsible for managing the Program, or by other specified activities identified on the Program website.

**In the event any of a participant's EMBARQ accounts are disconnected due to failure to pay, such participant shall be removed from the Program and all unredeemed Rewards Dollars will be forfeited.**

Embarq reserves the right to terminate the Program at any time. No additional Rewards Dollars will be awarded from and after the Program termination date. If the Program is terminated by Embarq, Customers will be notified and will have ninety days from the date of notification during which to redeem any unused Rewards Dollars. Any Rewards Dollars not redeemed within that ninety day period are forfeited.

Misappropriation of Rewards Dollars or the violation of the Program terms may lead to appropriate administrative and/or legal action by Embarq, including but not limited to forfeiture of all accrued Rewards Dollars. Rewards Dollars may not be combined with or applied to other certificates, promotions or special offers, special rate programs, including, but not limited to: upgrades, tour/travel packages, group, internet, convention/company meeting, senior rates, companion rates, 3rd or 4th person rates, student or child rates, early bookings or value added price programs or repeat passenger or repeat guest programs, or industry discounts. Rewards Dollars cannot be combined with or transferred between any other Embarq partner reward program.

Neither Embarq nor any other supplier of any reward will have any liability whatsoever for redemptions made in good faith to individuals who claim to have authority to act on a Program participant's behalf. Embarq is not liable for errors or omissions by its employees or agents in interpreting or in carrying out the terms of this Program. Any and all tax liabilities arising from the Program are the sole responsibility of the Program participant.

- g. Termination Liability Charges will not apply when a service or rate element under a Term Discount Plan (TDP) arrangement is disconnected prior to the expiration of a selected service period as a result of a change in tariff jurisdiction and/or a customer requested upgrade to a next generation service offering under the following conditions:

The service period of the new TDP arrangement for the new service offering is a period equal to or exceeding the remaining service period of the disconnected TDP, whichever is greater, and

The service orders to install the new service and disconnect the old service are related together, and there is no lapse in service between the installation of the new service the disconnection of the existing service, and

The service orders to install the new service and disconnect the old service are for the same customer at the same location.

The Telephone Company will determine whether replacement service qualifies as a next generation service offering.

Nonrecurring charges and Service Charges for the new service will apply according to the requirements of the new service.

**Service Charges are waived for one, two, three and five year term commitments when the customer also subscribes to the Company's non-regulated 1.5 Dedicated IP Service.**

CC. EMBARQ BUSINESS REWARDS PROGRAM

For the purpose of this sub-section A13.CC. concerning the EMBARQ Business Rewards Program, the term "Embarq" refers to Embarq Florida, Inc. and all Embarq Local Operating Company affiliates. The term "Company" refers solely to Embarq Florida, Inc.

EMBARQ Business Rewards Program ("Program") is an Embarq business customer loyalty program. The program allows customers who meet certain criteria set by the Company to earn Rewards Dollars that can be redeemed for various travel and entertainment products/services or other non-telecommunications/non-regulated products and services. Available Rewards options may change at the discretion of the Company and are provided for customer redemption on an availability basis. The Company does not guarantee availability of any option. In order to redeem Rewards Dollars, program participants must be current on payment of all their Embarq account(s).

All business customers who subscribe to services provided by the Company under this tariff and/or to Embarq High-Speed Internet (each an "Eligible Service") are eligible for enrollment in the Program. There is no charge to enroll and no term or volume commitment associated with the Program. Customers may terminate their participation in the Program at any time by notifying the Company. Eligible customers may activate their enrollment in the Program by calling an Embarq business office or in response to targeted Embarq contacts with eligible customers.

Customers enrolled in the Program will receive one Rewards Dollar for each dollar of Qualifying Usage (as defined below) the customer spends on Eligible Services. Qualifying Usage is calculated based upon the sum of the customer's monthly recurring charges for Eligible Services usage, less any applicable discounts, taxes, surcharges, FCC charges, 911 charges, or nonrecurring charges. Nonrecurring charges include service connection charges and installation charges. Rewards Dollars will accrue monthly based on the customer's Qualifying Usage. Qualifying Usage only may accrue after the customer enrolls in the Program. To earn Rewards Dollars, the enrolled customer must have an active account and that account must be in good standing, as determined by Embarq. Rewards Dollars have no direct monetary value, have no cash surrender value, and are only good towards redemption of the various products/services provided by Embarq.

In addition to the standard Rewards Dollars earned as outlined in this tariff, participants may, from time to time, be awarded additional Rewards Dollars (including bonus rewards) based upon specific purchases or actions. Consistent with applicable Commission requirements, a separate promotional filing will be made with respect to any such rewards that are based upon the purchase of regulated products or services or subscription to other tariffed offers.

If a Program participant discontinues subscription to all Eligible Services, Program participation will be terminated and all accumulated and unredeemed Rewards Dollars will be forfeited, unless such customer maintains Program eligibility based upon spending with other participating Embarq companies. A Program participant may not redeem Rewards Dollars against a canceled account. If the former Program participant (1) returns to Embarq for the same or substantially equivalent services within ninety days of terminating services; (2) re-enrolls in the Program; and (3) requests reinstatement of forfeited Rewards Dollars, such Rewards Dollars will be reinstated.

If a program participant fails to "actively participate" in the Program during any one-year period following Program enrollment, Program participation will be terminated and all accumulated and unredeemed Rewards Dollars will be forfeited. Termination Liability Charges will not apply when a service or rate element under a Term Discount Plan (TDP) arrangement is disconnected prior to the expiration of a selected service period as a result of a change in tariff jurisdiction and/or a customer requested upgrade to a next generation service offering under the following conditions:

The service period of the new TDP arrangement for the new service offering is a period equal to or exceeding the remaining service period of the disconnected TDP, whichever is greater, and

The service orders to install the new service and disconnect the old service are related together, and there is no lapse in service between the installation of the new service the disconnection of the existing service, and

The service orders to install the new service and disconnect the old service are for the same customer at the same location.

The Telephone Company will determine whether replacement service qualifies as a next generation service offering.

Nonrecurring charges and Service Charges for the new service will apply according to the requirements of the new service.

Service Charges are waived for one, two, three and five year term commitments when the customer also subscribes to the Company's non-regulated 1.5 Dedicated IP Service.

7. Service Components

- a. Administrative Charge – Applies to changes in a customer's network configuration such as additions or changes of PVCs. Although multiple changes can be caused by such actions, only one administrative charge applies.
