6. Miscellaneous Services and Rates

6.1 Service Connection Charges

Service Connection Charges are one-time nonrecurring charges for establishing or modifying telephone services. Service Connection Charges are incurred pursuant to Customer requests only.

Unless specifically exempted in this or other Sections of this tariff, Service Connection Charges apply to all Customer-initiated requests, and are in addition to all other scheduled rates and charges.

Service Connection Charges reflect service provided during regularly scheduled work hours, at current installation intervals and without work interruptions by the Customer.

Service Connection Charges for the initial establishment of telephone service are payable with the first bill rendered for service, *unless otherwise specified elsewhere in this tariff.*

Service Connection Charges do not apply for the reestablishment of service for the same Customer at a location which has been destroyed or made untenable by fire, wind, or water. Service Connection Charges do apply for establishment of service at a new location for a temporary period, for establishment of service at a new and permanent location, or for reestablishment of service at the same location for other than the previous Customer.
