**3.10 ACN DigitalTalk Express Dedicated Basic Fax Line \*\* (T)**

ACN DigitalTalk Express Dedicated Basic is a business fax service that provides customers with unlimited local<sup>1</sup> and 300 minutes of long distance calls within US and Canada. This service is only available to customers also subscribed to ACN DigitalTalk Express<sup>2</sup> and is intended only for fax use.

**3.10.1 Service Features**

ACN DigitalTalk Express Dedicated Basic Fax Line includes the following features:

- Unlimited local calls<sup>1</sup>.
- 300 minutes of long distance calls within the United States and Canada.

**3.11 DigitalTalk Data/Fax Line**

DigitalTalk Data/Fax Line is a business service that provides customers with unlimited local<sup>1</sup> minutes and access to long distance calling within the United States and Canada. Customers may order up to a maximum of three (3) lines. This service is only available to customers also subscribed to ACN DigitalTalk Services<sup>2</sup> and is intended for use with analog non-voice devices for faxing, security system monitoring and point-of-sale.

**3.11.1 Service Features**

DigitalTalk Data/Fax Line includes the following features:

- Unlimited local calls.<sup>1</sup>
