Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company ("TECO") requests confidential classification of certain information contained in the deposition of Jeff Chronister, filed May 28, 2024. This is a follow-up to a previous Motion for Temporary Protective Order DN 03025-2024, filed May 14, 2024. More specifically, the information which confidentiality is sought relates to the allocation of affiliate expenses.

According to TECO, the confidential information has to do with TECO's unregulated affiliates, and so TECO is not required to publicly disclose information related to their competitive interests, as that would impact the ability of the companies to do business.

Staff has reviewed TECO's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04310-2024 be approved.
