NOTICE TO CUSTOMERS

Dear Customer:

Under the provisions of Public Service Commission Order No. PSC-15-0569-PAA-WS Orchid Springs Development Corp. is required to reduce their wastewater rates based on full amortization of wastewater treatment plant removal and land remediation costs.

On November 4, 2025, Orchid Springs Development Corp. filed implement the required reduction.

The Commission staff has reviewed the filing for accuracy and completeness.

The actual across-the-board wastewater rate reduction is approximately 5.2%.

These new rates will go into effect on January 1, 2026 and will appear on your bills for all meter readings 30 days on or after that date.
