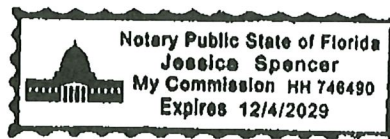

CUSTOMER NOTICE

Under the provisions of the Florida Public Service Commission Order No. 2015-0569-PAA-WS Orchid Springs Development Corp. is required to reduce their wastewater rates based on the full amortization of the wastewater treatment plant removal and land remediation costs.

Orchid Springs Development Corporation was granted a rate increase by the Florida Public Service Commission in Order No. PSC-2015-0569-PAA-WS, in Docket No. 20140239-WS. The ten-year amortization period for removal of the wastewater treatment plant and land remediation costs has expired. Effective January 11, 2026, the rates will be reduced as follows:
