Charlotte County Utilities (CCU) is concerned about your failure to respond to our official notice dated ____, to pay the necessary connection fee and connect to the potable water system.

Charlotte County Code Chapter 3-8, Article VII, Section 3-8-233 requires that each property on which a building is situated shall pay the required connection fee and shall connect to the County's potable water distribution facilities within 365 days following notification to do so by the County. This notice provides you with an additional 20 days to comply. At that time, the monthly potable water Base Facility Charge will begin to accrue and will appear on your CCU utility bill in the next billing period.
