Notice of Pre-AIA or AIA Status

1. The present application, filed on or after March 16, 2013, is being examined under the first inventor to file provisions of the AIA.

Response to Amendment

2. Applicant's Amendment filed 01/20/2022 has been entered. Claims 1-3, 5-13, 15-19, and 22 remain pending. Applicant's amendment to incorporate the limitation of Claim 21 into independent Claims 1, 11, and 16 overcome the 35 U.S.C. 103 rejection of Claims 1-3, 5-13, 15-19, and 22.

Response to Arguments

3. Applicant's arguments, see Pages 10-12, filed 01/20/2022, with respect to the 35 U.S.C. 103 rejection of Claims 1-22 have been fully considered and are persuasive. The 35 U.S.C. 103 rejection of Claims 1-22 has been withdrawn.

Allowable Subject Matter

4. Claim 1-3, 5-13, 15-19, and 22 allowed.

The following is an examiner's statement of reasons for allowance:

The most pertinent prior art is Riland (US20160343093). The prior art Riland teaches a utility resource asset management system for evaluation of weather, terrain, and utility data for the determination of damage predictions with metrics, alerts, asset allocation, and response plans. The prior art Riland teaches the limitations "A storm damage response system

comprising: an inventory database configured to store inventory data associated with location and characteristics associated with power-providing equipment in the geographic area with respect to power generator systems; and a storm damage model control system configured to implement a storm damage model algorithm to generate a predictive storm response plan comprising an operational procedure for repairing or maintaining the power generator systems to mitigate storm damage impact; calculate a statistical impact value indicative of a cost-based resource allocation estimate associated with the probabilistic model based on an aggregate of a plurality of iterative probabilistic simulations for the probabilistic model, the storm damage model control system comprising the relative statistical impact value of the probabilistic model of each of the plurality of ensemble forecast models to generate the predictive storm response plan.” The secondary prior art Ravela (US20070168155) teaches the limitations “a storm ensemble database configured to store a plurality of ensemble forecast models associated with respective potential storm paths of a given storm across a geographic area, as provided from and updated by a weather forecasting service; the storm damage model algorithm being configured to generate a probabilistic model for each of the plurality of ensemble forecast models and to calculate a statistical impact value indicative of a cost-based resource allocation estimate associated with the probabilistic model based on an aggregate of a plurality of simulations for the probabilistic model associated with the respective one of the plurality of ensemble forecast models to generate the predictive storm response plan”. The tertiary prior art Altschule (US20180156940) teaches the limitations “comprising a scenario comparator configured to select the probabilistic model associated with a respective one of the plurality of ensemble forecast models”. The combination of Riland, Ravela, and Altschule is silent with

regard to the limitation “the storm damage model algorithm being configured to generate a probabilistic model associated with the operational failure of the power-providing equipment relative to time, cost, resource availability, and storm severity constraints for each of the plurality of ensemble forecast models” and there is no such evidence which suggests that one of ordinary skill in the art would modify the storm response plan to use the inventory data of the time, cost, resource availability, and storm severity constraints in the generation of the probabilistic model. This is an improvement to the planning and allocation of resources for a storm response relating to the statistical impact based on probabilities of the for the storm forecast. Using the probabilistic model that is associated with the time, cost, resource availability, and storm severity constraints allows for the preparation for the maintenance of power systems and preventative care of power systems to mitigate the impact of the storm on the power systems.
