Only one comment from me. Since this PA is addressing one undertaking for Section 106 purposes, there needs to be one final finding of effect for the undertaking. Stip. III.B.1.c. should refer to Project, rather than resources under consideration. The provisions under Stip. IX should allow for construction to begin in some areas, before the final finding of effect. Otherwise the changes look acceptable to me.

We are reviewing the Archaeology Testing Plans and will send comments for those in the next few days.
