**FPL's Response to CLEO/Vote Solar's Second
Interrogatories No. 117.**

QUESTION:

Refer to Witness Bores direct testimony at p.10, line 23 - p.11, line 1.

- a. Indicate the timeframe over which the findings are accrued.
- b. Provide the breakdown in savings between former Gulf customers and former FPL customers.


RESPONSE:

- a. The \$2.8 billion of CPVRR benefit for customers associated with the FPL and Gulf consolidation consists of \$1.5 billion projected CPVRR benefits from generation planning and joint dispatch and \$1.3 billion of projected CPVRR benefits related to the reductions in Gulf's O&M expense after its acquisition by NextEra Energy (NEE) in 2019. The \$1.5 billion CPVRR net benefit projection is for the years 2020 through 2068, consistent with all current long-term resource planning evaluations. The \$1.3 billion of CPVRR benefit for customers associated with the Gulf O&M savings is accrued over 30 years (2022 through 2052).
- b. FPL has requested rate consolidation in this proceeding; therefore, the \$2.8 billion CPVRR benefit will ultimately accrue both to former Gulf and FPL customers. Please refer to FPL witness Sim's direct testimony for a discussion of the three-step resource planning analysis and Table SRS-Summary showing the CPVRR benefit associated with each step of the analysis. As discussed in FPL witness Sim's testimony, Steps 1 and 2 assume that FPL and Gulf are separate utility systems, therefore the associated CPVRR benefit would accrue to Gulf customers. Step 3 assumes integrating Gulf and FPL systems into a single utility system, therefore the incremental CPVRR benefit associated with Step 3 would benefit all customers.
