- N. SPRINT SOLUTIONS - BUSINESS (T)
1. General
- a. Sprint Solutions is an optional business service enrollment plan. The Plan permits a customer to receive features and services for a flat monthly rate, for each Sprint Solutions Package business line provided. Sprint Solutions includes two or more of the following features and services: (T)
- 1) Flat Rate Basic Local Exchange Service; (T)
- 2) Either a 60 minute block of time for Message Telecommunications Service (Local Toll), with Business Sense Local Toll rates applicable for each additional minute; or the option of subscribing to Business Sense Local Toll Service with per minute of use rates applicable for all local toll minutes as specified in Section A18, D.4. of this tariff, and (T)
- 3) A Custom Calling Feature Package or an individual custom calling feature. Custom Calling Features and Packages are described in Section A13 of this tariff. (T)
2. Regulations
- a. Sprint Solutions customers may terminate their enrollment in the Plan at any time upon notice to the Company. (T)
- b. Unless terminated by the Sprint Solutions customer or the Company, a customer will remain enrolled in the Plan, as amended from time-to-time, with any applicable changes in rate, for as long as the Plan continues to be offered by the Company. (T)
- c. The Plan is not available with Business ISDN-BRI Service lines, in conjunction with Pay Telephone Service, to customers who are or become toll restricted **or to customers with five (5) or more business lines per location**. Rotary Hunt Service, as defined in Section A3, is not available in conjunction with the Plan unless Rotary Line Service is included in a specific Sprint Solutions Package. The Plan cannot terminate to a Key System, PBX **or any other line trunking device**. **There can be only one business line per Solutions account and no more than three (3) Solutions accounts with the unlimited local calling option per location.** (N)
- d. No more than four (4) business lines can be enrolled with the Sprint Solutions option for each customer **location, except for Sure Solution II, Sprint Priority Solution and Rotary Classic Solution with the unlimited local calling option, which may have no more than three (3) lines.
