#### Sprint Business Sense \$0.10/minute Promotion

Sprint Custom Access Solutions T1 Bundle 1000 Minute Block of Time

Beginning August 1, 2005, business customers may be eligible to receive a 66.7% discount off the Monthly Service Charge for Sprint Block of Time for Small Business (Option B). In addition, the Overage Per Minute Rate will be applied at \$0.04 per minute.
