4.1.7 Option G (Prism Plus)

4.1.7.1 Prism Plus Calling Card Feature

Available to all Option G customers via 950 or 800 access.

Interexchange Facilities Usage Charges:

950 Access: The per minute usage rates for 950 access are set forth in Section 4.1.7.

800 Access 1/: The per minute usage rates for 800 access are charged the following rates:

Access Charges: The Prism Plus (Option G) Card per call surcharge as specified in the Service Agreement and Rate Schedule at <http://www.mci.com/service> is \$1.04.

Volume Discounts: Prism Plus Calling Card usage is eligible for all volume discounts set forth in Section 4.1.7. Prism Plus Calling Card usage will be combined with basic Prism Plus usage to determine volume discount thresholds.

Friends of the Firm: A discount of 20 percent will be applied against all gross qualified intrastate usage and surcharges.

4.1 METERED USE SERVICE (Cont.)

4.1.13 Option M (Commercial Dial 1 Service)

4.1.13.1 Minimum Spending Fee

Customer Account Minimum Charge: The Customer Account Minimum Charge applies when the Customer's total Option M combined monthly eligible usage is less than the Customer Account Minimum Charge specified below.

Eligible usage is defined as all Option M Dial-1 and Option M Card usage and surcharges (not including any non-recurring, monthly recurring (excluding Customized Business Program monthly recurring), Directory Assistance, 1-800-COLLECT, Local Exchange Carrier Calling Card, and taxes).

Customer Account Minimum Charge is \$5.00 per account if total Option M eligible usage charges are less than \$5.00 per account per month. The \$5.00 charge is applied against the month's usage charges.

The Customer Account Minimum Charge will be prorated, based on the number of days in the monthly billing cycle, when the Option M Account is furnished to the Customer for less than a full billing month due to the Customer establishing an Option M Account during a monthly billing cycle.

4.1.13.3 Operator Assistance, Local Exchange Company Calling Cards and Payphones: Service is provided according to the provisions and rates described in Sections 3.5.1 and 4.1.1.

4.1.13.4 Directory Assistance: An undiscounted charge will be applied to each Directory Assistance call, in accordance with and subject to the provisions set forth in Section 2.6.4 of this tariff.

Time of Day Discount Periods: Commercial Dial 1 Service offers an Evening Discount as well as a Night Weekend Discount at the rates specified in Section 4.1.13.2, for calls placed within the time periods as set forth in Section 1.

4.1.101 Option XXXX (Verizon Business Services II) (Cont.)

4.1.101.1 LD Voice Package

Customer will pay the following flat rate monthly recurring charge ("MRC"), fixed for the Term of the Agreement, for all intrastate and interstate outbound Long Distance calls from any single Customer site up to 20,000 minutes per month originating from a T1 or PRI purchased from Verizon.

Agreement Term	MRC*
One Year	\$725.00
Two Years	\$685.00
Three Years	\$650.00

* Overage Rate: Customer will pay a per-minute charge of \$.05 for each minute in excess of 20,000 in a month.

Customer understands that the LD Voice Package is restricted in the following manner:

- (i) International long distance, Inbound (toll free), and calling card minutes are NOT included.
- (ii) Customer may not utilize auto-dialers or any similar type of device in connection with the LD Voice Package.
- (iii) Customer may not utilize the LD Voice Package in any call center environment or in connection with any such similar environment.

CUSTOMER EXPRESSLY ACKNOWLEDGES THAT ANY VIOLATION OF THE FOREGOING RESTRICTIONS WILL RESULT IN THE IMMEDIATE TERMINATION OF THE LD VOICE PACKAGE BY VERIZON AND THE RESUMPTION OF STANDARD RATES FOR AFFECTED SERVICES.
