2 COMMISSIONER GRAHAM: Good morning, everyone.
3 Come on. We can do better than that. Good
4 morning.

5 (Good morning from the audience.)

6 COMMISSIONER GRAHAM: There we go.

7 I have to tell you it's great seeing all the
8 pink ties, and pink shirts, and pink blouses. And
9 as most of you know, this is the beginning of
10 breast cancer awareness month, and it's always been
11 one of those things that's been near and dear to my
12 heart, and I thank all of the staff and my
13 colleagues that all participate. Every year it
14 looks good, and I am very, very happy to see it

9 So tomorrow I am going to go down and just be
10 with them and helping in the restoration efforts
11 any way that I can, so -- but just thank you for
12 giving me the time to just say a few words for all
13 those people we are thinking and praying about you,
14 so thank you.

15 COMMISSIONER GRAHAM: Commissioner Clark.

16 COMMISSIONER CLARK: I just want to say as
17 well, our hearts go out to the individuals who are
18 suffering through the damages that this hurricane
19 caused. Four years ago, the Panhandle went through
20 a very similar incident, and we are still, four
21 years later, seeing the effects. It's going to be
22 a long recovery process.

23 I just want to encourage those individuals who
24 are experiencing -- still experiencing power
25 outage, who have experienced the loss of their

1 homes, to remain strong, and there is hope, and the

6 restore the lives of these individuals that have
7 been affected. And I just want to let everyone
8 know that our thoughts and prayers continue to be
9 request them, Mr. Chairman.

NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE OF AUTHORITY

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code (F.A.C.).

Peering Hub Inc. (Peering Hub) applied for a Certificate of Authority to provide telecommunications service, pursuant to Section 364.335, Florida Statutes (F.S.). Upon review of the application, it appears that Peering Hub has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Peering Hub Certificate of Authority No. 8977, which shall authorize Peering Hub to provide telecommunications service throughout the State of Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, F.S., and Chapter 25-4, F.A.C. In addition, under Section 364.336, F.S., certificate holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year.

A RAF Return notice will be mailed each December to Peering Hub for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Peering Hub from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Peering Hub's certificate. Peering Hub shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, F.S.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Peering Hub Inc.'s application for a Certificate of Authority is hereby granted. It is further

ORDERED that Peering Hub Inc. is awarded Certificate of Authority No. 8977, which authorizes Peering Hub Inc., to provide telecommunications service throughout the State of Florida, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Peering Hub Inc.'s certificate and shall be retained by Peering Hub Inc., as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further



- B) Docket No. 20220133-EI - Application for authority to issue and sell securities during calendar years 2023 and 2024, pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Florida Power & Light Company and Florida City Gas.

Florida Power & Light Company (FPL or Company) requests authorization to issue and sell and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser or surety in an aggregate amount not to exceed \$8.1 billion during calendar year 2023.

In addition, FPL requests authorization to issue and sell short-term securities during the calendar years 2023 and 2024 in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of and including any such sale shall not exceed \$5.15 billion.

Florida City Gas (FCG) requests authorization to make long-term borrowings from FPL in an aggregate amount not to exceed \$300 million during 2023 and make short-term borrowings from FPL in an aggregate principal amount not to exceed \$150 million at any one time during calendar years 2023 and 2024.

In connection with this application, FPL confirms that the capital raised pursuant to this application will be used in connection with the regulated activities of FPL and FPL's subsidiaries, including FCG, and not the nonregulated activities of its subsidiaries and affiliates.

Staff has reviewed FPL's projected capital expenditures. FPL's construction budget forecast for 2023 is \$8.036 billion for FPL and \$53 million for FCG. The amount requested by the Company (\$13.25 billion, of which \$450 million is for FCG) exceeds its expected capital expenditures (\$8.089 billion in 2023). The additional amount requested exceeding the forecasted capital budget expenditures allows for financial flexibility for unexpected events such as hurricanes, financial market disruptions, and other unforeseen circumstances. Staff believes the requested amounts are appropriate. Staff recommends FPL's application for authority to issue securities during calendar years 2023 and 2024 be approved.

Recommendation: The Commission should approve the actions requested in the dockets referenced above and close Docket Nos. 20220132-TX and 20220129-TX. For monitoring purposes, Docket No. 20220133-EI should remain open until May 3, 2024, to allow the Company time to file the required Consummation Report.
