GetGo Communications LLC has requested cancellation of Certificate No. 8851, effective July 17, 2023. The certificate holder has complied with Section 364.335(3), Florida Statutes, by providing the Florida Public Service Commission notice in writing of its request for voluntary cancellation of its certificate.

Neither the cancellation of the certificate nor the failure to receive a RAF return notice shall relieve GetGo Communications LLC from its obligation to pay RAFs. This includes the obligation to pay any penalty and interest that may be due for the current year. Failure to pay the amounts owed to the Florida Public Service Commission will result in the Company's fees, penalties and interest being sent to a collection agency.

Pursuant to Section 2.07.C.5.f., Administrative Procedures Manual, the voluntary cancellation is acknowledged and the docket should be closed.

**Re: *GetGo Communications LLC – Notice of Request for Termination of Authorization to Provide Telecommunications Services***

Dear Mr. Teitzman,

GetGo Communications LLC (f/k/a Citrix Communications LLC, "GetGo" or "the Company"), through undersigned counsel, hereby notifies the Florida Public Service Commission of its request to withdraw the Certificate of Authority ("CoA") No. 07055-13, in Docket No. 130186-TX (granted by Order No. PSC-13-0608-CO-TX, effective November 19, 2013) to provide competitive local exchange carrier services, and withdraw any tariffs on record, effective as soon as possible.


GetGo's business model has continued to evolve and develop since its CoA was originally granted. Today, the Company has no telecommunications customers of any kind. Therefore, the CoA granted by the Commission is no longer necessary.

The public convenience and necessity will not be adversely affected by the action described herein. No customer is currently receiving regulated telecommunications services from the Company, and therefore, no customer will have service interruptions or disconnections. GetGo no longer provides regulated telecommunications services in Florida. All previous customers have been transferred to other providers. GetGo does not serve any residential or mass market consumers, so no notice period is necessary.

To the best of its knowledge, the Company is current on all reporting and fee remittance obligations. Wherefore, GetGo hereby requests cancellation or withdrawal of its Florida CoA and tariffs as soon as the Commission can take appropriate administrative action.
