The 2023 Regulatory Assessment Fee (RAF) Return Form for Gold Data USA Inc. (Company Code TY210) was mailed December 8, 2023, to the Company's most current address on file at the Florida Public Service Commission (PSC or Agency):

The RAF Return Form and RAF payment were due on January 30, 2024. The PSC has not received this payment. Multiple attempts via phone and/or email to contact the Company and resolve this matter have been unsuccessful. Either the Company did not answer the call, return the Agency's voicemail message, or respond to the email message informing it of the delinquent RAF status.

The PSC mailed a certified letter to the utility regarding its delinquency on February 20, 2024, urging the Company to pay its outstanding RAF's, along with the assessed late penalties and interest, in order to avoid a non-compliance docket being opened. This attempt also resulted in no response from the Company. Therefore, a non-compliance docket is scheduled to be opened on **April 19<sup>th</sup>, 2024** which will address the Company's delinquent RAF status and will seek cancellation of the Company's certificate if payment is not received through this process. Once the non-compliance docket is opened, a RAF non-compliance fee will be automatically assessed to the Company's RAF account (\$500.00 for first-time violations, \$1,000.00 for second-time violations, and \$2,000.00 for third violations).

As of today, April 15, 2024, the Agency still has not received the 2023 RAF payment from Gold Data USA Inc. If the Company wishes to avoid the opening of a non-compliance docket, please find the RAF Return Form attached to this email, complete the form, include a check for payment (i.e. RAF amount due, plus late penalties and interest), contact our office, and mail it as soon as possible to the following address:
