Pursuant to Section 364.33, AT&T Communications of the Southern States, LLC and AT&T Corp. hereby provide notice to the Florida Public Service Commission of the acquisition by AT&T Enterprises, LLC of AT&T Corp. which holds Certificate of Necessity No. 4037 (TA062). AT&T Enterprises, LLC and AT&T Corp. are wholly owned subsidiaries of AT&T Inc.

Effective May 1, 2024, AT&T Corp., through a series of intercorporate transactions, was merged into AT&T Enterprises, LLC with AT&T Enterprises, LLC being the surviving entity. Pursuant to the merger, AT&T Enterprises, LLC has acquired control of Certificate 4037 (TA062). AT&T Enterprises, LLC has assumed provision of the services provided by AT&T Corp. For regulatory purposes involving Certificate 4037 (TA062), AT&T Enterprises, LLC should be substituted for AT&T Corp. 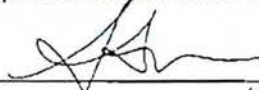
