ORDER GRANTING SIX-MONTH EXTENSION FOR UTILITY  
 TO SANDBLAST AND REPAIR GROUND STORAGE TANK

By Order No. 17245, issued on March 5, 1987, this Commission ordered the Broadview Park Water Company (Utility) to make certain improvements to its facilities to be completed within 12 months of the date of implementation of the higher rate established in that order. Since the higher rates were implemented on April 27, 1987, the due date for completion of the required improvements was April 27, 1988.

On March 27, 1988, the Utility informed the staff that it was unable to meet the twelve-month deadline and therefore was requesting a six-month extension. Since the main concern of the Commission was that the quality of service be brought to a satisfactory level, the Commission granted the Utility's request in Order No. 19497.

On August 22, 1988, the Utility notified the staff that it had completed all but one of the improvements, that is, it had yet to sandblast and repair the ground storage tank. Since we believe the primary focus should be on the completion of the improvements and since the Utility appears to be near compliance, we shall grant this last extension.

In consideration of the foregoing, it is

ORDERED by the Florida Public Service Commission that the time limit for the Utility to complete the improvements required in Order No. 17245 shall be extended to April 26, 1989. It is further

ORDERED that Docket No. 860726-WU shall remain open until staff verifies that the Utility has made the required improvements.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
