AMENDATORY ORDER

BY THE COMMISSION:

By Order No. 22871, issued April 30, 1990, this Commission proposed to establish increased rates and charges for the Duval County water and wastewater systems of Southern States Utilities, Inc. (Southern States). The schedules containing the proposed water and wastewater rates and the proposed allowance for funds prudently invested (AFPI) charges were, however, somehow omitted from Order No. 22871. Accordingly, by Order No. 22871-A, issued May 14, 1990, we amended Order No. 22871 to include the rate schedules as Schedules Nos. 7-A and 7-B, and the AFPI schedules as Schedules Nos. 8-A and 8-B for water and wastewater, respectively.

On May 21, 1990, Alvin R. Weikel, a customer of Southern States, filed a protest to Order No. 22871. Pursuant to his protest, this case was set for an administrative hearing. Mr. Weikel failed, however, to file any testimony or a prehearing statement. Accordingly, by Order No. 23419, issued August 29, 1990, we dismissed his protest and revised and consummated Order No. 22871.

Upon further review of Orders Nos. 22871 and 22871-A, it has come to our attention that the AFPI amounts depicted on Schedules Nos. 8-A and 8-B did not include property taxes which, by Order No. 22871, we had found to be an appropriate element of those charges. Therefore, by this Order, we hereby amend Orders Nos. 22871 and 22871-A to replace Schedules Nos. 8-A and 8-B with the identically numbered schedules attached to this Order. All other provisions of Orders Nos. 22871 and 22871-A remain unaffected by this Order.

It is, therefore,

ORDERED by the Florida Public Service Commission that Orders Nos. 22871 and 22871-A are hereby amended to replace Schedules Nos. 8-A and 8-B with the identically numbered schedules attached to this Order. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer

utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
