
NOTICE OF ADOPTION OF RULE AMENDMENT

(e) Are filed within 21 days after the date the transcript was received by this agency.





SUMMARY OF RULE

Rule 25-24.520 is amended to adopt a form for pay telephone companies to use when making their annual report to the Commission.

SUMMARY OF HEARINGS ON THE RULE

No hearing was requested and none was held.

FACTS AND CIRCUMSTANCES JUSTIFYING THE RULE

Rule 25-24.520 required pay telephone companies to report certain information to the Commission's Division of Communications by January 31 of each year, but no form was provided for the companies to use. Consequently, the reports that were received were often incomplete and there was no uniform format used by companies to report the information required. The Commission has adopted a one-page form to be used by all the pay telephone companies that requests the same information that has previously been listed in the rule. The only additional information required by the new form is the name of the person responsible for contact with the Commission and the company's certificate number. Minor changes in the wording of the rule have been made to clarify its meaning.
