

ORDER GRANTING MOTION TO COMPEL
REQUEST FOR PRODUCTION OF DOCUMENTS

On July 23, 1990, Comtel of Orlando, Inc. (Comtel) filed an application for a certificate to provide pay telephone service. On October 9, 1990, the Commission issued Order No. 23595 denying Comtel's application. Comtel filed a protest of Order No. 23595 on October 29, 1990. Staff served its first request for the production of documents on February 6, 1991. Comtel failed to provide the requested documents or file any response to the request. On April 11, 1991, staff filed a Motion to Compel a response to the request. No response was received.

Because Comtel has not shown any reason why the requested documents have not been produced, staff's Motion to Compel is granted. Comtel of Orlando, Inc. is directed to respond to staff's first request for the production of documents within twenty (20) days of the date of this Order.

administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: 1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; 2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or 3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or sewer utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
