NOTICE OF PROPOSED AGENCY ACTIONORDER CANCELING TARIFF GROSS-UP AUTHORITY

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and, as such, will become final unless a person whose interests are substantially affected files a petition for a formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

The repeal of Section 118(b) of the Internal Revenue Code (I.R.C.) resulted in making contributions-in-aid-of-construction (CIAC) gross income and depreciable for federal tax purposes. In Order No. 16971, issued December 18, 1986, the Commission authorized corporate utilities to collect the gross-up on CIAC in order to meet the tax impact resulting from the inclusion of CIAC as gross income. Florida Cities Water Company (Golden Gate Division) requested and was granted authority to gross-up.

In Order No. 23541, issued October 1, 1990, we determined that any water and wastewater utilities already collecting the gross-up on CIAC and wishing to continue collecting the gross-up, had to file a petition for approval with the Commission on or before October 29, 1990. Because Florida Cities Water Company (Golden Gate Division) failed to file a timely petition for approval to continue to collect the gross-up, it is no longer authorized to collect the gross-up on CIAC. Therefore, the utility's tariff sheets reflecting authority to gross-up CIAC charges are hereby

Based on the foregoing, it is, therefore

ORDERED by the Florida Public Service Commission that Florida Cities Water Company (Golden Gate Division) is no longer authorized to collect the gross-up on CIAC. It is further

ORDERED that the tariff sheets described in the body of this Order are hereby canceled. It is further

ORDERED that the provisions of this Order are issued as proposed agency action and shall become final unless an appropriate petition in the form provided by Rule 25-22.036, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on the date set forth in the "Notice of Further Proceeding or Judicial Review" attached hereto. It is further

ORDERED that this docket shall be closed if no timely protest is received from a substantially affected person.
