NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING PAY TELEPHONE CERTIFICATES

BY THE COMMISSION:

Notice is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

The individual companies listed in the caption of this Order filed applications for a certificate to provide pay telephone service (PATS). These applications were filed pursuant to Section 364.3375, Florida Statutes (1990), which provides that no person can provide pay telephone service without first obtaining from this Commission a certificate of public convenience and necessity to provide such service. Section 364.335 provides for the application for a certificate of public convenience and necessity and sets forth guidelines for the application process. The application requirements are further defined in Rule 25-24.511, Florida Administrative Code.

PATS providers are subject to the provisions of Rules 25-24.505 through 25-24.520, Florida Administrative Code, which govern the operation of PATS.

In reviewing the applications of these companies, we find that they contain the information required for certification as set forth in Sections 364.3375 and 364.335, as well as the Rules cited above. Based on the foregoing, we propose to grant each of the companies listed in the caption of this Order a certificate to provide pay telephone service consistent with the conditions and requirements set forth in Rules 25-24.505 through 25-24.520, Florida Administrative Code.

The dockets listed in this Order will be closed following expiration of the period specified in this Order unless an appropriate petition for hearing, protesting a specific application, is filed by one whose substantial interests may or will be affected by this proposed agency action, as provided by Florida Administrative Code Rules 25-22.029 and 25-22.036(7)(a). A petition protesting a specific application filed by one whose substantial interests are affected will not prevent our proposed action from becoming final as to any other application listed in this Order.

It is, therefore,

ORDERED by the Florida Public Service Commission that each of the applicants listed in the caption of this Order is hereby granted a certificate to provide public pay telephone service subject to the conditions stated in the body of this Order. It is further

ORDERED that a petition protesting a specific application, filed by one whose substantial interests are affected, will not prevent the action proposed herein from becoming final as to other applications listed in the Order. It is further

ORDERED that the effective date of these certificates is the first working day following the date specified below, if no protest to the proposed agency action is filed within the time frame set forth below. If there is no such protest, this docket shall be closed at the end of the proposed agency action period.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

The action proposed herein is preliminary in nature and will not become effective or final, except as provided by Rule 25-22.029, Florida Administrative Code. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, as provided by Rule 25-22.029(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a) and (f), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting at his office at 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on October 29, 1992.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
