25-9.053 <u>Filing and Evaluation of Information to Accompany</u> Submittals.

(1) Each letter transmitting a utility's proposed documentation in which any change in rate structure is proposed shall be accompanied by the following items in connection with each new and existing service classification:

(1) As applicable a tabulation setting forth, at appropriate consumption levels, the charges applicable under the present and proposed rate together with the difference expressed in dollars and in percent; and

(2) <u>Ssupporting information in sufficient detail as to allow</u> the Commission to determine the derivation of all rate structure modifications. <u>The supporting information shall consist of either</u> <u>a utility-specific cost study or an analysis of utility-specific</u> <u>cost and operating data prepared using a methodology previously</u> <u>approved by the Commission for any comparable utility.</u> All additional relevant information deemed necessary by the Commission shall be submitted in addition to the above upon request.

(2) The utility may submit actual cost and operating data to support its proposed change in rate structure. If the utility does not submit such supporting information actual cost and operating data, the Commission shall evaluate the proposed change in rate DOCUMENT NUMBER-DATE structure on the basis of cost and operating data from one or more Comparably situated public electric utilities which the Commission FPSC-RECORDS/REPORTING ORDER NO.
